

**OFFICIAL RULES  
NO PAYMENT, ENTRY FEE OR PURCHASE REQUIRED.**

**OPEN TO RESIDENTS OF THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA AND PUERTO RICO. ENTRANTS MUST BE AT LEAST 18 YEARS OLD AT TIME OF ENTRY OR HAVE THE EXPRESSED CONSENT OF A PARENT OR LEGAL GUARDIAN. VOID WHERE PROHIBITED.**
